Minutes

Thursday, March 13, 2025, 6:30 p.m.

1. Call to Order

President Jaramillo called the meeting to order at 6:30 p.m. All members were present. President Jaramillo announced that all open sessions of the board meeting are audio-recorded and may capture the sounds of those participating in the meeting. President Jaramillo asked those participating in the meeting to join in the Pledge of Allegiance.

2. Public Comment on Agenda Items

Pursuant to Board Policy 9324, Minutes and Recordings: "The minutes shall reflect the names of those individuals who comment during the meeting's public comment period as well as the topics they address."

- A. Comments on agenda items.
 - Antoinette Jenson commented regarding the district financial report, preschool tuition fee increase, financial discrepancies, Local Control Funding Formula (LCFF) funding, teacher credentialing, misuse of public funds, and improper use of Medi-Cal billing.
 - Des Alvarez commented on the February and prior meeting minutes inaccuracies, parental rights regarding police interviews, homework policies, field trip cancellation, financial transparency, i-Ready alternative, bullying, contract for a public relations service, and concerns over the resources for Community Day School students.

3. Review / Adopt Agenda and Minutes

- A. The Board of Trustees adopted the agenda as presented on a motion by Member Gordon, seconded by Member Fort, and carried by a unanimous vote with all members present voting yes.
- B. The Board of Trustees adopted the minutes of the regular meeting held on February 12, 2025, as presented on a motion by Member McAllaster, seconded by Member Karsch, and carried by a unanimous vote with all members present voting yes.

4. Educational

A. Kerry Hackman, Principal of Etiwanda Colony Elementary School, Assistant Principal Christine Reed, and teachers Kate Gye and Teri Serl presented "Really Great Reading, Really is GREAT!" They highlighted the program's impact on phonological awareness and phonics across all grade levels, showcasing significant student growth.

5. Instruction

A. After discussion, the Board of Trustees took action to approve the recommendation of continued placement of Community Day School on the campus of Summit Intermediate for the 2025-2026 school year on a motion by Member Fort, seconded by Member Karsch and carried by a unanimous vote with all members present voting yes.

6. Business and Legal

- A. Michael Mancuso, Director of Fiscal Services, presented the Second Interim Financial Report through January 31, 2025.
 - Board members discussed the uncertainty surrounding federal funding, which accounts for 2% of the overall budget, and how it was considered in the multiyear projections.

After discussion, the Board of Trustees took action related to the Second Interim Financial Report through January 31, 2025, and authorization of the Board President and Superintendent to sign a positive certification for the Second Interim District Certification of Interim Report for the Fiscal Year 2024-25, on a motion by Member Gordon, seconded by Member McAllaster, and carried by a unanimous vote with all members present voting yes.

6. Business and Legal (continued)

- B. Michael Higgins, Director of Operations and Facilities, presented the Summit Intermediate School M-Wing Replacement Bid/Project #24/25-070.
 - Board members confirmed we have either worked with the recommended contractors or demonstrated they are committed to quality work. Members confirmed that tariff changes would not impact metal-related components in the bid, and bidders must honor their submitted prices.

After discussion, the Board of Trustees took action to award Summit Intermediate School M-Wing Replacement – Bid/Project #24/25-070 to the listed contractors in the total amount of \$19,995,220.00 as presented on a motion by Member Gordon, seconded by Member McAllaster, and carried by a unanimous vote with all members present voting yes.

7. Superintendent

- A. After discussion, the Board of Trustees took action to change the regular board meeting date from May 8 to April 30, and May 29, 2025, did not change, on a motion by Member Gordon, seconded by Member Karsch, and carried by a unanimous vote with all members present voting yes.
- B. After discussion, the Board of Trustees took action to approve the draft 2025-26 board meeting dates on a motion by Member Fort, seconded by Member Karsch, and carried by a unanimous vote with all members present voting yes.
- C. After discussion, the Board of Trustees took action to approve the speakers for the 8th grade promotion ceremonies scheduled for May 22, 2025, on a motion by Member Gordon, seconded by Member McAllaster, and carried by a unanimous vote with all members present voting yes.
- D. Superintendent Sprague recognized Board Member Dr. Fermin Jaramillo for completing the California School Boards Association's Masters in Governance program, joining Board Members Dayna Karsch and Cathline Fort. She also acknowledged the 2025 San Bernardino County Spelling Bee winners, congratulated participants in the Battle of the Books (BOB) event, and thanked volunteers Amber Claflin, Melissa Kvalheim, Doug Claflin, and library staff for their efforts. Additionally, she highlighted a visit from San Bernardino County Superintendent, Ted Alejandro, to observe the Advancement Via Individual Determination (AVID) program at Etiwanda Intermediate, shared updates on Crossing Guard Appreciation Day, recent site visits, and social media engagement, and informed the Board of upcoming district events.
 - Board member April McAllaster informed the Board that Superintendent Sprague was recognized by the California Legislature in Sacramento as Woman of the Year in honor of Women's History Month. This honor was awarded for her accomplishments and contributions to the Etiwanda School District and for her groundbreaking achievement of serving as a Superintendent in a traditionally male dominated field.
