#### 2. PUBLIC COMMENT ON AGENDA ITEMS

Because this is a special meeting, members of the public may only comment on agenda items. Because there are time limits imposed for public comment, neither the Board nor the Superintendent answer questions or respond to statements made during the public comment. Members of the Board or the Superintendent may choose to take notes and respond briefly after public comment is closed. Individual speakers shall be allowed up to three minutes to address the Board on each agenda item. This time may be shortened based on the number of speakers or issues to be addressed at the Board's discretion. If a member of the public desires to be heard on more than one item appearing on the agenda, he or she will be allowed up to a total of five minutes to address all desired agenda items with a maximum of three minutes per agenda item. For agenda items, in order to ensure that non-English speakers receive the same opportunity to directly address the Board, any member of the public who utilizes a translator shall be provided twice the allotted time to address the Board, unless simultaneous translation equipment is used to allow the Board to hear the translated public testimony simultaneously. Board Policy 9323 limits the total time for public input on each agenda item to a maximum of thirty minutes. This time may be shortened based on the number of speakers or issues to be addressed at the Board's discretion. The Board assumes no responsibility for the speaker's liability for any intentionally false or defamatory comments the speaker may make regarding any person during the opportunity for public comment. Persons who have complaints against employees of the District are encouraged to seek resolution of those complaints by utilization of the Etiwanda School District written complaint procedure rather than orally addressing them at a meeting.

### REPONSE FROM BARON BROWN TO "CANDIDATES' APPLICATION QUESTIONS" 01/19/23

ь. к

- 1. I DO NOT have children who currently attend school in the Etiwanda School District (ESD), but I do have a grandson who is attending an ESD middle school and a granddaughter who will most likely attend an ESD elementary school in a few years.
- 2. I HAVE NOT participated on any school committees or participated in any school activities recently. However, I'm a recently retired faculty member from nearby Chaffey College in Rancho Cucamonga, and I was both a president and a senator on the Chaffey College Academic Senate, a formally trained career and academic adviser, dept. chair and educational program manager for the Chaffey College Prison Education program. I also served as a faculty advisor and supporter for several demographically identified, student-centered campus organizations (UMOJA, PUENTE, Veterans, Student Government, Justice System-impacted and Former Foster Youth organizations). Thus, having worked on an academic legislative body and two homeowners' associations, I am familiar with both the Brown Act requirements for legislative bodies and Robert's Rules of Order for governance.
- 3. Re: community or business volunteer activities, I'm a former foster parent and a seasoned public speaker who has presented on behalf of sexually and physically abused women and children, current and former foster youth, and disabled or combat-impacted military veterans.
- 4. I'd like to be a member of the Board of Trustees for several reasons, but the most compelling inspiration is in my blood; I'm the child of a career educator and I've been a career educator myself. In reviewing the lack of preparedness (both empirically and via reviewed research) for a concerning percentage of students entering college, I can see that we need to attack the issues of "life and career preparedness" MUCH earlier than the last 2 years of high school, which is when most students (and secondary educators) start to identify the "post-high school" possibilities for students. I'm confident that my 25 years of experience at the community college and university level, knowledge of sound pedagogical approaches and my imminent doctorate in educational leadership (Spring 2023) can truly benefit fellow Board members and District educational professionals alike. It simply seems like a GREAT opportunity to make a substantial difference in the lives of our ESD students.
- 5. In my personal and professional opinion, I believe that the purpose of the public school system is to *provide access to quality education for ALL students in its area of responsibility,* which is much in the spirit of historic educator Horace Mann's vision.
- 6. The Board of Trustees has several important responsibilities in ensuring that the basic purpose of ESD, as a CA public school district, is met (in reference to question #5). The Board must serve as prudent and responsible stewards of the public educational funds; provide legislative governance for the overall management of ESD; appoint and ensure that ESD has a knowledgeable, ethical, capable and uncompromised superintendent/CEO and campus principals who reflect those same qualities; ensure that hiring and promotional practices are sound, fair and reflective of the demographic diversity of the students and families that it serves; and to substantially limit the risks, conflicts of interests and potential financial losses that ESD may face going forward.
- 7. The Board has a *legislative* set of responsibilities (budget, oversight, etc.) as opposed to an *operational* set of responsibilities in the discussion of the relationship between the Board and the administration of a specific school. The Board appoints (or approves for hire) competent and capable executives and managers to run the daily campus operations and to develop strategic plans at the campus and district levels, but the Board provides the operational, legal, budgetary and state-mandated legislative oversight of the District.

8. In my opinion as a parent, taxpayer and educator, I believe that the strengths of ESD are: a robust budget; consistent and reliable funding sources; HIGHLY-trained and qualified educational professionals; and supportive, engaged parents. ESD is also greatly benefitted by having a robust and engaged Board of Trustees.

- 9. As with virtually every K-14 public school district in the nation, the area of the highest need for improvement is the operational and strategic planning to meet the needs of an increasingly diverse student body and constituency. I moved to Rancho Cucamonga from L.A. in 1988, and I have seen REMARKABLE changes in the "visible demography" of the city. With these changes I haven't witnessed significant demographic changes in faculty and staff across the district, nor in campus or District-level leadership. With that said, are ESD's efforts sufficient to meet the needs of ALL of its students across the demography? I believe that it's a work in progress, and that this will be the biggest challenge for ESD for the next 15-20 years, in light of the rapid demographic changes in ESD's area of responsibility. I don't just assert this as a parent, grandparent or potential Board candidate. I am also a Diversity, Equity and Inclusion officer for a SOCAL city, so this is both my "world of work" and the lens through which I view public policy and equitable opportunities for all students.
- 10. The Board and the Superintendent roles vary GREATLY. In short, as is the case with a publicly-traded corporation like Google, Northrup-Grumman or Microsoft, the Superintendent is the CEO, ultimately responsible for the overall performance, trajectory and direction of the District. The Board, on the other hand, has responsibilities for fiscal planning and budgetary commitments for the District; monitoring of performance indicators and considering recommendations for district-wide improvements, or improvements to underperforming campuses; provide "a voice and ear" for the constituents in the District's area of responsibility.
- 11. My commitment to public education in ESD has been articulated throughout several of my responses but, in short, I have been a resident of ESD for almost 30 years, having sent approximately 12 children to matriculate in ESD as a biological, foster and adoptive parent; and I have taught many ESD graduates at Chaffey College, Azusa Pacific University, National University and the University of Phoenix's local campuses. I vote in local elections and worship locally. I am committed to the areas that are served by ESD and to the Inland Empire as a whole.
- 12. In order to improve communications and relationships among the Board and various stakeholders is multifaceted. First, the Board MUST insist on establishing and maintaining transparency in their monthly and strategic operations on behalf of constituents and institutional stakeholders. This can be obtained through pensive efforts via a highly-capable public information officer (PIO) and Office of Public Information. The efforts should be through the encouragement of public comments in face-to-face settings, webcasted and videotaped sessions, explanation of closed session procedures, and an interactive social media presence. Board members should also have obligations to engage with the community via local special events. Additionally, through broader, more diverse professional representation throughout the District's various faculty, staff, management and executive positions, both insights and inroads will be obtained for communities that have been historically marginalized or underserved. These are just two ways to improve communications.

I believe that this position is vitally important and deserves utmost time and consideration. I have an abundance of experience to offer. I also have ample time to devote to the position. I spend time writing emails and calling our local leaders when items that affect our students are being debated. I know the Board is a place where we can exert positive influences for our community. - 5. The basic purpose of the public school system is to prepare children for a world that does not yet exist. With times and technology changing so rapidly, the world will be a completely different place than we can even imagine when these students graduate. The public school system provides a safe environment where children receive an academic education that will prepare them for future learning and success. The public school system teaches children to set high expectations and goals for themselves, and prepares learners for self-sufficiency in adulthood.
- 6. The Board of Trustees advocates for the students and identifies needs within the district. They are a crucial connection point between the community and the school district. The Board of Trustees sets the tone with the Superintendent to ensure that policies are followed, and that excellence in education is

- 12. In order to improve communications and relationships among the Board, staff, students, parents and community, I would propose two suggestions. First, the current system of emailing the board is not user-friendly. It is difficult to find the link. And when typing a message, the sender can only see a small portion of it. If you want to reword part of a message, it is extremely difficult and you basically end up backspacing all the way back to that one spot. It is frustrating. And after that, you never know if it actually sent or not. I have used this system multiple times to email the board, and a majority of the time, I have never known whether or not it was received. Many times I just ended up calling Dr. Judson to discuss an issue, but thankfully through that we became friends. I believe we can easily make improvements to this system. When people feel that they can reach the board and are heard, a connection is made. The board can then "see people" and forge relationships. My next suggestion about how to improve communication is taken from what I've witnessed Jeff Sipos and David Apodaca do. They host "Coffee and Donuts with the Principal" every few months, and invite parents to come out and ask questions. We have had nearly 100 people come out. I think it would make a difference to the public if we could do something similar to this, and if the board could have more of a public presence. Again, if we can establish relationships with the public during the good times, then we will be in a better position when the challenging times come.



# 10. How does the Board's role differ from that of the Superintendent?







- 1. Yes, my son Zachary Rebick is nine years old and attends Windrows Elementary School.
- 2. Yes, I acted as a chaperone for Zachary's field trip to the Mary Vagle nature center. My wife and I have participated in the scholastic book fair, classroom help, and purchasing/delivering pizza's to the staff for staff appreciation. I also participated in staff appreciation week at Saint Mary's Montessori where I prepared meals and served them to each and every staff member.
- I have been coach or assistant coach to all of Zachary's city sports including baseball, football, soccer, and basketball. I have also participated in many different city events with the City of Ontario including Halloween celebrations, Christmas celebrations, reindeer runs, and community outreach events.
- 4. Education is by far the single most important thing in a child's life. It helps them develop critical thinking and problem solving skills that will be used for a lifetime. It also opens up many doors that otherwise would not be available to someone without an education. Education is very important to me and is pushed very heavily in my household, which is why I want to be a part of the decision-making processes that influence our current and future generations. I want to be able to do something that makes me and my family proud and also do something where the decisions I make show an actual difference in a child's development. I have over seven years of public service experience, so when you combine this with my love for education I was immediately drawn to the School Board Trustee announcement.
- 5. I believe the basic purpose of the public school system is to give an equal opportunity education to all youth, regardless of race, gender, or socioeconomic status. The public school system is funded and by state and local governments, therefore, the public school system is not vastly different than private school since we are all paying for it some form or another. Also, public schools typically require certain education and certificates for teachers to possess in order to become a public educator. This makes sure that all teachers have the same basic education and can provide a quality education at any school. Public school systems also offer much more diversity and prepare children to eventually be a contributing member of society.
- 6. The role of the Board of Trustees in the fulfillment of the purpose stated above is to make sure that all these basic principles are continually adhered to and applied equally. They must act as an advocate for children, the district, and their respective schools. They must also set direction, provide structure, and make sure that everyone is held accountable. It is also important that they stay flexible to allow for the ever-changing policies that can sometimes change overnight and without warning.
- 7. The relationship between the Board and the administration should be one that is not only mutually beneficial, but one that promotes progress as opposed to stagnation. School concerns are something that need to be dealt with head-on and in a timely fashion. There are typically multiple different stakeholders involved in any one particular issue, and most of them will want to have guidance and structure in place as quickly as possible. In order for this to be done, both the Board and the administration need to be able to work together efficiently.
- 8. The Etiwanda School District has many strengths. The biggest strength I see is the amount of funding we receive. The average resident of the Etiwanda School District typically pay much higher taxes than surrounding cities due to higher incomes. This allows the district to put more emphasis into education. The average member of our community is also deeply involved in their children's education and believe that a strong school district is what makes this area so special.

The combination of higher funding and students that excel in academics allow this district to continually stay on top in regards to ratings and test scores. Another strength that I see is that this district pays its staff higher than normal wages for the area. This ensures that not only does the district retain its staff for much longer, but it also allows the district to be very selective when it comes to hiring.

- 9. One of the biggest areas in need of improvement, which affects just about every government entity is time. Getting things approved and implemented typically takes much longer than in the private world. Approval processes are much more stringent and usually delay things heavily. Perhaps there is a way we can streamline some of the processes and eliminate some of the downtime so that we can get programs rolled out faster so that everyone can benefit from them. Another issue that I see is that the district does not offer enough after-school activities, both physical and mental, primarily for the K-6<sup>th</sup> grade students. I know of other neighboring districts that offer more after-school programs than our district does. I would like to see more of these implemented in our district.
- 10. It is typically the role of the superintendent to identify issues or needs, recommend policy changes, provide guidance, and manage day-to-day operations of the district. The Board of Trustees must evaluate those issues or needs, and recommend or implement district-wide policy changes. These recommendations or policies must be implemented while keeping the district's budget and timeline in mind, as well as the interest of any other stakeholders that may be affected by them. The Superintendent and the Board need to work together to make these transitions as smooth and efficient as possible.
- 11. My commitment to public education in the Etiwanda School District is to serve our youth to the best of my ability using my previous work experience, education, and life experience and to make sure that each and every child gets a top-tier education. I will set aside any bias and/or politics that try to persuade my decision-making and make sure that the children are my number one priority at all times. I will help the Etiwanda School District to maintain its top quality public education system and will work towards making it the number one school district in the country.
- 12. I think communication can be improved in many different ways. One way is to make sure that everyone has a chance to meet everyone face to face. Although the pandemic gave us the gift of being able to meet any place and any time, this also takes the human factor out of the equation. We are social creatures by nature and need to be able to see one another to build a strong relationship with them. I think getting everyone together in a public setting on a semi-regular basis would help build and improve these relationships. Another way would be to make sure that everyone gets a chance for input before a final decision is made. A lot of times people feel "left out" or that their vote did not matter in the decision making process. I think it is important to offer a chance for everyone being affected by new policy to have a chance to offer their own input. # 2. Have you worked on any school committees or participated in any school activities recently? If yes, please list them.

I had the opportunity this past summer to work with the principal and some administrative staff of Rancho Cucamonga High School to present a scholarship award that I was the committee chair representing the National Football League's Players Association. A female senior student was recognized for her academic and athletic achievement, who was awarded a scholarship to help supplement her effort of going to college. That student was one of 30 females in the country to win the award. It is a passion of my heart that I am active in community and mentoring.

# 3. Describe any community or business volunteer activities you have joined or organized.

- Q: Do you have children who attend school in the Etiwanda School District? If yes, please share ages of student and their schools. Currently, I have two of my four children enrolled within the Etiwanda School District. My 9 year old is a current third grader at Windrows Elementary School while my 6 year old just began kindergarten at Windrows Elementary School. I also have a 15 year old that successfully completed middle school at Etiwanda Middle School last year before moving on to Rancho Cucamonga High School this year. Right behind these three is a 2 year old eager to start at Windrows Elementary School as soon as possible.
- 2. Q: Have you worked on any school committees or participated in any school activities recently? If yes, please list them. I have not had the opportunity to serve or participate in any school committees or participate in any school activities within the Etiwanda School District.
- 3. Q: Describe any community or business volunteer activities you have joined or organized. Within the Rancho Cucamonga community, I havel volunteered with The Y's Highland Run for multiple years. I have also had the opportunity to participate as a volunteer coach for my children and community with Vineyard Little League and the Local i9 Sports Organization.
- 4. Q: Why do you wish to be a member of the Board of Trustees? - 6. Q: What is the role of the Board of Trustees in the fulfillment of that purpose? The Board of Trustees, as a collective, creates and promotes district policy, directs the superintendent (evaluation/hire/terminate) and maintains the solvency of the District's budget. The board's role is to ensure that the district is responsive to the values, beliefs, and priorities of the community. the board works with the Superintendent to fulfill its major responsibilities, which include: setting the direction of the district through community engagement, focusing on student achievement, establishing an effective organizational structure for the district (hiring superintendent, setting hiring policies, development and adoption of policies, establish academic expectations, adoption of the budget, provide safe and adequate facilities,, and sets parameters for labor negotiations. The Board also ensures accountability to the public on school performances and provides advocacy on behalf of students. Beliefs, decisions, and actions of school boards directly impact the conditions within schools that enable district efforts to improve achievement to either succeed or fail. The Board has a role in creating the condition necessary for student achievement.
- 7. Q: What should the relationship between the Board and the administration in the handling of school concerns? The Board works collaboratively with the superintendent on a uniform response to school concerns. A protocol shall be developed to ensure that messaging is consistent and appropriate for each concern. The Board is responsible for establishing or

updating board policy due to recent changes to the education code or state law. The superintendent or designee will oversee the handling of school concerns. The superintendent will keep the Board apprised of the handling of such concerns.

- 8. Q: What do you see as the strengths of the Etiwanda School District? The Etiwanda School District has been one of the highest achieving academic elementary school districts in our state for decades. Our teachers provide engaging lessons in all curriculums for all students. The Etiwanda School District also promotes inclusion of all students. All district employees are dedicated to creating a safe environment for every student to achieve. Our district also has an outstanding level of parent involvement and support both on campus and in the home.
- 9. Q: What do you see as the areas most in need of improvement in the Etiwanda School District? The Etiwanda School District is currently in a period of transition. With a new Superintendent and three new board members, this team will need to create a vision for where they see the Etiwanda School District in 5 years. The leadership has a challenge in that the previous team of board members and superintendent were well rooted into the organization and worked side by side for many years. We have the opportunity to grow into the next phase of Etiwanda's success. Being that the Etiwanda School District is one of the lowest funded districts in San Bernardino County, we will need to continue to focus on being fiscally solvent while providing our children with the resources needed to be productive citizens in our global society.
- 10. Q: How does the Board's role differ from that of the Superintendent? As elected leaders, the board's role is to be representative of the constituents in the district while carrying out their duties. The role of the board is also to support the Superintendent and all district administration in their duties. Different from the Board, the Superintendent also focuses on the day to day operations of a school district. The Superintendent is also the bridge between the board and the district staff, communicating the vision and building systems to support the vision. The Superintendent should always act in the interest of students and in accordance with the direction set by the board.
- 11. Q: Briefly describe your commitment to public education in the Etiwanda School District. Etiwanda School District holds a special place in my life. I attended Kindergarten through 5th grade at Lightfoot Elementary, Golden for the one year it was all 6<sup>th</sup> grade students, and then to Summit Intermediate for my 7<sup>th</sup> and 8<sup>th</sup> grade years.
