1. Call to Order

Board President Karsch called the meeting to order at 6:30 p.m. When the meeting was called to order, all members were present. Board President Karsch announced that all open sessions of the board meeting are video and audio recorded and may capture sounds and images of those participating in the meeting. Board President Karsch asked those participating in the meeting to join in the Pledge of Allegiance.

2. Public Comment on Agenda Items

Pursuant to Board Policy 9324, Board Minutes and Recordings: "The minutes shall reflect the names of those individuals who comment during the meeting's public comment period as well as the topics they address."

A. Comments on agenda items: None Offered

3. Review / Adopt Agenda and Minutes

- A. The Board of Trustees adopted the agenda as presented on a motion by Member Gordon, seconded by Member Garcia, and carried by a unanimous vote with all members present voting yes.
- B. The Board of Trustees took action to adopt the minutes of the regular meeting held December 15, 2022, as presented, on a motion by Member Garcia, seconded by Member Gordon, and carried by a unanimous vote with all members present voting yes.

4. Instruction

- A. Jeannie Tavolazzi, Assistant Superintendent of Instruction/Pupil Services, presented information on the adoption of the Teachers' Curriculum Institute (TCI) Social Studies Alive! textbooks for Grades K-5. Ms. Tavolazzi presented the goals and timelines. She shared the review of materials and pilot phases and the input from staff, families and students and shared future trainings and resources.
 - ➤ Board members asked how long TCI has been around and if there are any controversial issues. Ms. Tavolazzi shared the company has been around for 30-plus years and the Fair Act requires materials to be reflective of the diversity of the community and does not teach about any particular lifestyle.
 - ➤ Board members asked about accommodations for parents on supplemental materials, potential changes to TCI materials once adopted, and what other districts are using the materials. Ms. Tavolazzi shared that TCI materials are state-approved and are not expected to change after adoption. Teachers have the option to use supplemental materials as long as they follow board policy. There are 43 districts that have adopted these materials and the cost for the programs was similar.

President Karsch opened the Public Hearing regarding the adoption of the Teachers' Curriculum Institute (TCI) *Social Studies Alive!* textbooks for Grades K-5. No comments offered. After hearing no comments, President Karsch closed the public hearing.

The Board then took action to adopt the Teachers' Curriculum Institute (TCI) Social Studies Alive! textbooks for Grades K-5 as presented on a motion by Member Gordon, seconded by Member Jaramillo, and carried by a unanimous vote with all members present voting yes.

- B. Rebecca Pierce R.N., B.S.N., P.H. N., Health Services Coordinator, and Ashley McKinnon, District Nurse, presented the Naloxone Implementation plan. They shared background, California Education Code, laws and liabilities, implementation plan, and employee training.
 - Board members asked about training and educational information for students. Ms. Pierce shared the District is using American Red Cross CPR training and is ordering CPR masks to avoid close contact with the face.

After discussion, the Board of Trustees took action to approve the Naloxone Implementation Plan as presented, on a motion by Member Jaramillo, seconded by Member Gordon, and carried by a unanimous vote with all members present voting yes.

After discussion, the Board of Trustees took action to approve the revisions to Board Policy 5141.21 Administering Medication and Monitoring Health Conditions, Administrative Regulation 5141.21 Administering Medication and Monitoring Health Conditions and Administrative Regulation 5148.1 Child Care Administering Medication, as presented, on a motion by Member Gordon, seconded by Member Garcia, and carried by a unanimous vote with all members present voting yes.
- F. David Ortiz, Director of Data, Assessment and Accountability, presented information on the California School Dashboard.
 - > Board members discussed absenteeism, breakdowns and comparison to other districts.
