1. Call to Order

Board Clerk Karsch called the meeting to order at 6:30 p.m. When the meeting was called to order, all members were present. Board Clerk Karsch announced that all open sessions of the board meeting are video and audio recorded and may capture sounds and images of those participating in the meeting. Board Clerk Karsch asked those participating in the meeting to join in the Pledge of Allegiance.

2. Public Comment on Agenda Items

Pursuant to Board Policy 9324, Board Minutes and Recordings: "The minutes shall reflect the names of those individuals who comment during the meeting's public comment period as well as the topics they address."

A. Comments on agenda items: None Offered.

3. Administration of Oath of Office to Board Members

A. Superintendent Charlayne Sprague administered the Oath of Office to two-elected Board Members Dr. Fermin Jaramillo and Matthew Gordon, and one appointed in-lieu of election Board Member Dayna Karsch, to the office of the Etiwanda School District, Members of the Governing Board, as certified by Registrar of Voters of the County of San Bernardino.

4. Review / Adopt Agenda and Minutes / Annual Organizational Meeting Election of Officers

- A. The Board of Trustees adopted the agenda as presented on a motion by Member Long, seconded by Member Garcia and carried by a unanimous vote with all members present voting yes.
- B. Annual election of officers was held for the Board of Trustees.
 - 1. Board Clerk Karsch opened the nomination for President. Member Karsch was elected President on a motion by Member Long, seconded by Member Gordon, and carried by a unanimous vote with all members present voting yes.
 - 2. President Karsch opened the nomination for Clerk. Member Garcia was elected Clerk, on a motion by Member Gordon, seconded by Member Jaramillo, and carried by a unanimous vote with all members present voting yes.
 - 3. President Karsch opened the nomination President Pro Tempore. Member Long was elected President Pro Tempore on a motion by Member Jaramillo, seconded by Member Gordon, and carried by a unanimous vote with all members present voting yes.
 - 4. President Karsch opened the nomination for county representative. Member Jaramillo was elected county representative on a motion by Member Long, seconded by Member Garcia, and carried by a unanimous vote with all members present voting yes.
 - 5. The Board of Trustees took action to appoint Superintendent Sprague as Secretary to the Board on a motion by Member Garcia, seconded by Member Gordon, and carried by a unanimous vote with all members present voting yes.
- C. The Board of Trustees took action to adopt the minutes of the regular meeting held November 17, 2022, as presented, on a motion by Member Garcia, seconded by Member Long, and carried by a unanimous vote with all members present voting yes.

- A. Doug Claflin, Assistant Superintendent of Business Services, presented the installation of a bike repair station at Heritage Intermediate School for students and staff in memorial of Teacher Jim Williamson.

- Member Gordon commented he was glad to see the school site is remembering someone that was so important to their community and asked how much has been raised for the project and how much is still needed. Mr. Claflin shared that \$500.00 had been raised and an additional \$1,200.00 is needed.
- Member Jaramillo commented this is a beautiful way to honor Jim Williamson and his memories.

After discussion, the Board of Trustees took action to approve the installation of a Bike Repair Station at Heritage Intermediate School for students and staff to honor for Jim Williamson, as presented on a motion by Member Gordon, seconded by Member Garcia, and carried by a unanimous vote with all members present voting yes.

B. Michael Mancuso, Director of Fiscal Service, presented the First Interim Financial Report through October 31, 2022, and authorization of the Board President and Superintendent to sign a positive certification for the First Interim District Certification of Interim Report for the Fiscal Year 2022-23, and related budget transfers.

Member Gordon asked what is FTE. Mr. Mancuso shared that is Full-Time Equivalent, an employee that is full-time, 8 hours a day.

- Member Gordon asked about the Governor's proposed budget on January 15, and how that would affect us. Mr. Mancuso commented he has not gotten any reports for the Governor's office but the legislative office and UCLA are projecting a possible 50/50 recession, but nothing definite.
- Member Jaramillo commented that it looks like the Local Control Funding Formula (LCFF) is going back to categorical, which it was not the design. Mr. Mancuso shared it does feel that way, with a lot of one-time funding coming out and is unsure if that pattern is going to continue.

After discussion, the Board of Trustees took action to approve the First Interim Financial Report through October 31, 2022, and authorization of the Board President and Superintendent to sign a positive certification for the First Interim District Certification of Interim Report for the Fiscal Year 2022-23, and related budget transfers as presented, on a motion by Member Long, seconded by Member Jaramillo, and carried by a unanimous vote with all members present voting yes.

Superintendent Sprague shared where to find on the district website the information on the Local Control Accountability Plan (LCAP), ESSER III, Expanded Learning Opportunities Grant and Program Plans, Educator Effectiveness Block Grant, and Universal Prekindergarten Plan and the use of the money.

11. Superintendent's Presentation

- A. Superintendent Sprague shared student and staff recognition, West End SELPA Parent Project workshop, School Smarts PTA Parent Engagement Program, LCAP survey deadline and Rancho Cucamonga PTA Council Reflection Art Awards ceremony. She thanked Windrows for this month's board room decorations, shared social media updates and upcoming events.
 - Member Karsch asked if parents need to be chosen for West End SELPA program or they could enroll. Superintendent Sprague shared that parents can enroll and it is a free program.
 - Member Karsch asked if this is for children ages 1 10. Superintendent Sprague shared that there are two workshops, one for children ages 1-10 and one for ages 13 17.
 - Member Karsch encouraged families to complete the LCAP survey.
